SEARCH WARRANT

THE PEOPLE OF THE STATE OF CALIFORNIA TO ANY SHERIFF, POLICE OFFICER, OR PEACE OFFICER IN THE COUNTY OF SACRAMENTO:

Proof by affidavit having been made before me by **Ofc. Lucas**, that there is probable cause to believe that the property and thing to be seized, to wit, a blood sample from the person of **CERVANTES**, **SABRINA** is lawfully seizable pursuant to Penal Code Section 1524(a)(13) and/or Penal Code Section 1524(a)(17), as evidence that tends to show a violation of Vehicle Code Sections 23152 has been committed by **CERVANTES**, **SABRINA**.

STATEMENT OF PROBABLE CAUSE FOR SEARCH WARRANT FOR BLOOD SAMPLE (PENAL CODE §§ 1524(a)(13), 1524(a)(17))

I, Ofc Lucas, a peace officer with the Sacramento Police Department, state that I have been trained in the enforcement of California traffic laws, including detecting incidents of driving under the influence of alcohol and/or drugs.

On May 19th, 2025, at 1327 hours, Sacramento Police Officers investigated an incident of vehicle accident by CERVANTES, SABRINA (here in after "Suspect"), at 14th Street and S St in the County of Sacramento. CERVANTES, SABRINA had left the scene of the accident and responded to 6600 Bruceville Rd, Kaiser Hospital. CERVANTES, SABRINA was contacted by Sacramento Police officers at 6600 Bruceville Rd in a seated position wearing a black face mask and wearing large sunglasses in the emergency room waiting area. CERVANTES, SABRINA when first contacted by Sacramento Police Officers she appeared to have difficulty in getting to a standing position from her seated position. CERVANTES, SABRINA was walking approximately 75 feet from a waiting room to a private security room and Sacramento Police officers observed CERVANTES, SABRINA with an unsteady gait and when she removed her face mask and sunglasses she appeared to be drowsy while speaking with Sacramento Police officers. When Sacramento Police officers obtained a statement from CERVANTES, SABRINA they observed CERVANTES, SABRINA to have thick slurred speech, and at times she stumbled over the pronunciation of words during her statement. Based on the training and experience of the Sacramento Police officers who contacted CERVANTES, SABRINA the signs and symptoms she displayed are indicative to the impairment of the central nervous system based on the use of depressants.

CERVANTES, SABRINA denied the consuming alcohol prior to driving. When Sacramento Police officers asked CERVANTES, SABRINA to perform a Standardized Field Sobriety Tests to assist in the investigation she declined any and all Standardized Field Sobriety Tests and advised she would need to speak with the senate legal counsel first. Based on the training and experience of Sacramento Police officers who contacted CERVANTES, SABRINA and their experience in DUI investigations they recognized this to be a potential of a stalling tactic attempting to delay the investigation of DUI. CERVANTES, SABRINA then said she would be not provide a blood sample unless a warrant was obtained.
